Function One Sweet Cart Hire Terms and Conditions and Hire Agreement

Please read the following points carefully and sign the document, Failure to agree will lead to the cancelation of your booking. It is the responsibility of the customer (hirer) to ensure that all possible steps are taken to avoid injury or damage to the item(s).

Please ensure that the following safety instructions are followed:

- 1) Full payment must be made at the start or prior to your event.
- 2) Any threatening or antisocial behaviour towards ANY Function One Entertainment staff member will not be tolerated under any circumstances and could lead to the end of our services at the party or event.
- 3) Function One Entertainment will ensure any incidents are followed up and Function One Entertainment will support its staff to prosecute those involved
- 4) You must allow a minimum of 30 minutes for the set up of equipment.
- 5) You must allow a minimum of 30 minutes for packing equipment away.
- 6) Function One Entertainment are not responsible for any charges to you by the venue due to not allowing our minimum set up or pack down times.
- 7) Any incidents or complaints involving Function One Entertainment or its staff must be sent in writing to us within working 7 days of the issue.
- 8) Function One Entertainment can not take any responsibility for damage to a venue unless it is due to negligence of our staff.
- 9) Function One Entertainment can not take any responsibility for any injury or death of anyone at an event.
- 10) You the hirer must NOT add any of your own sweets or products to the cart unless it is agreed and on a dry hire.
- 11) The sweet cart must not be moved from where it is placed,
- 12) ONLY a Function One staff member may move or tamper with the cart.
- 13) I understand that all damages that occur during my hire will be charged to me and I agree to pay them as requested by Function One Entertainment.
- 14) No food, Drinks, Silly String etc to be near or on the sweet cart as this can cause damage or stain/mark the cart and will result in damage charges.
- 15) Do not allow the cart to get wet, This may cause the wood to swell and/or damage the paintwork and will result in a damage charge.
- 16) Any issues with the sweet cart or its contents must be reported immediately to Function One Entertainment on the contact number.
- 17) Function One Entertainment or its staff can not be held responsible for any issue regarding food allergies or intolerances as set out in our allergies information.
- 18) The sweet cart is owned and operated by Function One Entertainment and only our staff are authorised to collect or set up the equipment.
- 19) It is the responsibility of the hirer to ensure the venue is aware of the sweet cart being there and check with them about any rules or regulations they have.
- 20) I understand the sweet cart is for INDOOR Hire only and can not be used outside for any party or events.

Damage Charges
